- d. Open enrollment to renew insurance for staff as of December 1, 2010.

- f. Insurance safety program – one officer had an accident.
- g. Renting the hall-received \$30,000 in income. Manager recommends stopping the hall rental to outside residents. Manager stated the village does not have the staff to handle the rental. His estimate is that 80 percent are outside rentals.

Mayor Black asked if the cost of a police officer could be included in the rental fee.

- h. Conversations with the owners of the church. Manager requested that council make a definite decision on how to handle the church.
