Sandy Owens: Good evening council and everybody. Hello, residents and all of the others that are here. My name is officer Owens. I work for the El Portal Police Department for about 18 years, a little over 18 years. I've trained several officers throughout the years, well, more than several. Some of them gone on to bigger and better departments. Some went to the shores, city of Miami, Miami Beach and other departments. During that time, as a part-timer, I've been here 18 years. I've seen a lot, done a lot, I trained a lot of officers that still work here and some that have gone on.

The part-timers work and I just want to give you guys some insight about what we do as part-timers and the new guys that are coming onboard what they're about to get into. Basically, a time of part for at least 25 hours a month for volunteers. They're not paid. They're here to do that. These officers paved the way through their academy on their own. They're not paid by or was sponsored by anybody. When I started back in 1999 and retired in 2000, as a part-timer, besides doing a 20 hours reserve, they also paid us a fee to work shifts when they couldn't man them. We were only making \$10.12 in an hour.

That's a police officer back in 2000 as a part-timer. We would cover night shifts, midnight shifts, and that. When I started, I didn't think what I would see today that I've seen in 18 years. During my tenure year, I have responded to several hundred calls. I'm just going to give you a couple that I've responded to. One of them was during an event two years ago when the trailer park was opened. I responded to the death of a six-month-old child that passed away in the bed. I had to stay there for 11 hours with that child where I was being investigated.

I've also responded to a call with suicide. They found the body. I found the body two days later. Responded to the trailer park. A neighbor said they haven't seen the gentleman, an older gentleman for over a week. I had to call the fire department. We went inside. He had been dead for over a week. I've responded to many many calls here during that tenure. This officer are going to see a lot. People think that when you're a part-time, you're not going to see it. I responded to a call about five years ago. A 16-year-old was shot at Northwest, 90th Street, or that's where they brought the body too.

I responded, I gave a CPR until fire rescue arrived. She passed away on the scene. I was there for nine hours with a dead body. This is what they have to look forward to. Also, mostly these cops, and I know their residence, applaud us, they're happy we're here. I like them to understand that when we do a traffic stop, you wonder why two cops are on that traffic stop. It's for our safety and the benefit of the village. You may not see because of our limited staff. You might not see us for an hour or two because we're on that traffic stop, there be leads to arrest or something else.

We're maybe out of the city where we may lead one officer. If there's only one officer on Biscayne Park and North Bay Village and Miami Shores, they help us out a lot. Mostly, when we lead them on a night shift, they're there for us and we're there for them. It's a mutual related thing. When there's a short staff, they do give us a call, we respond. It's the brotherhood out there, but they work hard. Most of the cops that respond to our domestic violence calls or to traffic stops, they're two [unintelligible 00:07:24] in the world today. No other cops get killed going to those. I'll trim down the full-type positions several times. A whole lot of times. The reasons that I have, I know the village is small, the pay and the benefits wasn't just there, but I continue to work here.

Hopefully, I'll be around for a long time. These officers, the part-time officers, when they come to work, if they go to classes, if they want to better themselves, they have to take their own vacation time. They're still not paid to attend these training classes. Over the years, I am the only certified school resource officer in the village of [unintelligible 00:08:03]. I took a 40-hour class. I took a vacation a week. I'm also a field training officer. That's how I come train these people. It's another 40-hour class. Back in about four or five years ago, we go to Westmont to New Mexico to learn a bit. It was a bomb class.

Responding to bomb calls and everything else. 40-hour class, once your bus went, the federal government paid for it, but we took a long time to go there. All the training that I've received

and everybody else that's been here as part-timers to make us better as a unit and to complement the department, we do it on our own time. We don't get paid for it even we go to court, we take vacation time. Most of these guys with full-time jobs. They have children, they have a family. I've given up a lot in 18 years. I have two grown daughters. Let me go to page two because I'm not really reading it.

I have been through at least four to five police chiefs over the years. They've come and gone. Some stayed long and some stayed short. During that time, I've seen a lot of change. However, the change that I've seen recently is probably one of the best changes I've seen in the years. The strives that this department is trying to make to bring us up to code with compliance and everything else, is probably one of the best things that's ever happened to this department. It's hard for the new administration to make changes. I know because I'm one of those with values ones.

I've worked for the county for 29 years. Sent home a couple of times because I voiced my opinion. Now, I stay out of politics, I do my job. Change is hard for some people, but we may all have to make those changes for the better. The times had changed. It's just one of those things that I hope to see continue to change. I back the council People up there, I back the chief and the residents. Whatever changes that are made, I'm going to stick here and stay with it for as long as I can. Thank you for allowing me to speak.

Claudia Cubillos: Of course absolutely. Did you read the minutes? Did you have the opportunity to review the video?

Werner Dreher: Unfortunately, I did not review the video.

Claudia Cubillos: As you know for the last year this topic had been on the agenda, and at the January council meeting we had agreed that some of us had asked to move it to, I think it was the December meeting that Vice Mayor Nickerson had moved it several times because we wanted to always give the benefit of the doubt to our attorney who has been with us for a very long time. I believe it was the vice mayor, and if you want, you can intervene if you like, had made a recommendation that we'll do it in the February council meeting whether or not he is or he is not present.

He had missed the last meetings. We understand he was in session, and he wasn't at the last meeting. Our agreement to to go through a firm was more of a it's not one that we are tied to for a year two or three. In fact at that February meeting, once you review the minutes and video, it clearly indicates that we are asking to appoint an interim attorney because we must have an attorney on record, and thereafter go through an RFQ or whatever the process may be to seek that affirm or anything of that nature. I want to say it was a very benign, but a lengthy conversation because it hadn't been a conversation for several months now.

That's where the committee council had reached a vote. I believe Councilperson Mathis was there. He did ask to wait for the entire council to be here and with all due respect to the residents and to what we have to do, I believe that we've waited a really long time for the attorney. I want to also put in the record and I've said it over and over, it was never personal. Attorney Geller has been a friend of many of us up here. This decisions are always really hard to make especially as you create friendships and alliances with them. At the end of the day, and one of the things that I said and I would reiterate is that the way we do business today in the village is not the way we did business 5, 10, 15, 20 years ago.

A lot of our residents want answers and they want them today. It's really hard to give answers when there are not attached, or they are not blessed for lack of a better word, by the legal opinion. It's in the last six months as this fiscal year started, there were six contracts that were passed over due because we were ready for an attorney. Actually, I was reminded in a conference call by [unintelligible 00:24:14] that although his contract was passed two months ago, it's still not signed by the attorney. This is not in any way to make the attorney

look bad because he's a firms of ours and I even asked the current interim attorney if there could be a resolution that we did to honor Jo Geller's service in the village. This is more we are going to continue to wait on an attorney or are we just going to try get work done?

Waste management contract, past due, PBA contract, past due. I can really go on and on, this is not about defaming anybody or speaking poorly, it is about we need to get a job done, and we can't do it when all of us are not working. That was pretty much- this conversation has been going on for a year, and it was just reiterated again at the February that was in March meeting.

Werner Dreher: My question, I'm aware of these conversations. My concern is more, and this has nothing to do with the person it's more on the concern on the selection process that we carry to bring new people into the village. This is whether the previous attorney had his faults or whatever, my concern is here that we are being transparent to the community as far- let me finish.

Claudia Cubillos: I'll definitely answer that.

Werner Dreher: That's where I'm heading to. My concern is, there's a vote that's made during the council meeting, then how is this advertised, how is this person considered to be the temporary role that he's going to be playing. This is again nothing to disrespect their qualifications, but I'm more concerned that we are being transparent to the resident here. This had happened once and again, this has nothing to do with the village manager, this has we were at the same position, we had the village manager still in that out there and we still had the potential person sitting out in the audience.

We keep going through the same cycle and this is where I have my concerns. I brought it up during that selection process, as well to the village manager, this was nothing with respect to her performance, but I just want to make sure that we are being transparent to our residents on how we move forward with having our folks here. That's what I need to understand, how did the person being considered for a contract is sitting here today. Second, the honorariums that we were paying our previous attorney I understand was \$4000, now we are doubling the fee based on what I'm reading high level, I want to understand as well the logic why are we considering doubling the fee?

Especially I would like to understand as well why does the background I asked a couple of questions before we move inside and approve a contract?

Claudia Cubillos: I'm going to answer the first question, may I? Your first concern which is a valid one, which I left out. Part of being elected is important to attend meetings and when we can't, we have to really read minutes Councilperson Dreher. That's number one, with that said, at the February that was held I'm March, one of the things that I said was, that when we have to terminate a relationship with an attorney, we have to be quick in our feet. The last couple of months at the cities which you and I attend every month and I sat on the board I had met Norman Powell there. Just to the conversation and relationships that I've created with other mayor's most of them watch the videos of other towns.

They know what's going on. They had asked where we were at, and I said I really don't know. That's how I met Norman Powell, none of us sure are friends with Norman Powell when I introduced him on the record in March 5th which is the February council meeting. I read his bio, his bio I took down from the North bay village website. One of my recommendations or the reason I recommended was because the mayor and vice mayor of North Bay Village had spoken highly of him and they were in a tough position like us where they had to move forward to another attorney after having an attorney for so long.

When you have a relationship for so long, it becomes difficult to have to break it apart and move forward. When Norman Powell was recommended on an interim basis, that's how he was recommended and believe vice mayor Nickerson had made a comment with regards to how we met him at the meetings as well. Second to that, I know some of us have not been making some meetings, I believe the attorney has made the attempt to contact every elected official up here because I asked him to do so and he did. He did not hear from you.

I believe him and Councilperson Mathias had to reschedule, but I believe he's met with me, he's met with vice mayor Nickerson, and he's met with Councilperson Roman individually on different days and different times. He told me yesterday when he was here meeting with the manager and I that the only person that had not responded back was I believe you. Councilperson Mathias had a conflict and needed to reschedule. If we miss meetings, and the person that is being temporarily or interim appointed is contacting us, it is in our job and our due diligence to respond back and meet the person.

If you can't, then you do it over the phone especially when the meeting is missed. That would have allowed you the opportunity to really get to know him a little better and have a temporary opinion because to do an RFQ process right now will 30 to 60 days, which at the March 5th meeting, I strongly recommended that it should be done anyway. As we all know, a manager, an attorney and a clerk is mandatory by charter. An attorney had to be a point on an interim basis, and that's how he came to be.

To your last question in terms of transparency, one of the reasons why the videos are now uploaded on the website is because we are transparent, is because everything is done on the record. Again, and I'm going to reiterate a part of that is being present and having to be here and when we can, I understand we have conflict, we travel, we have work, and that's very respectable. We then we must do the due diligence of following through whether it's with the clerk, whether with the manager, whether it's reading the minutes, whether it's looking at the YouTube video or replying back to the individual that could potentially be a new attorney, a new manager, a new clerk.

I believe I think he made the attempt to contact all of us. I think those are your questions. I think you had-- How was he refereed which is Miami-Dade County League of Cities. [crosstalk]

Werner Dreher: I don't know. I'm still a little bit unclear.

Omarr Nickerson: It's only the mayor met with him. They decided she was going to bring him forward.

Vilamri Roman: It's mayor?

Claudia Cubillos: I want to retract because I don't believe that your statement is correct. The mayor met him at a Miami-Dade County League of Cities which you have met him too. I can vividly recall, and I don't have the emails, but the delay in him getting back to was weeks. One can attest to that because we were to copy those emails. He probably took-- I don't even remember how long he took. Nice man, smart attorney. He was present, but that process was lengthy, and he was delayed.

To me is sort of like emulated attorney Geller's the way he was treating us. Secondly, we've had Jason Silver, very nice attorney. He's come here several times, but when he does, he's unfamiliar with who we are, what we are, what we're doing. When we ask him a question, he's got to text Jo Geller. I actually met yesterday with him very briefly during the workshop. I know it was very brief. It was during the workshop it was no. If you did send out an email, but I'm not seeing here in my phone, my apologies.

My point here is I want to be transparent to our community, that we're doing our due diligence and advertising a position that we think a qualified candidate. I'm not saying you're unqualified, but we're doing that. My second question is, now why are we doubling the salary of this contract right from 4,000 to 8,000? I read the email from our consul person Roman that, yes, we compared to North Bay village. There's 8,000 that the current salary, but do we compare within our budget the same El Patel to North Bay villages as well?

Claudia Cubillos: My apologies. You're right I didn't answer the last question. I have it right here for you. Okay. I asked administration and finance, Owen, to please give me the last three years legal fees that we've paid. Just so you can all see the increase that we've had in the last three years because it's clear we're getting a little busier. When the fiscal year ended in 2015, we spent 21,000. When the fiscal year ended in 2016, we spend 50,000. When the fiscal year ended last September, we paid 74,000 legal fees. That's all to Jo in Greensburg.

Jo may have a retainer. It's not 4,000, it's 1,500. That doesn't all inclusive, there is we pay planning and zoning. We pay Jason when he comes here. Excuse me, Jason Silver, when he comes here. When you look at the numbers it's really not that far off. Our current attorney, the contract when read is asking for 8,000 a month. It would turn out to be 96. If we decide to keep him, which I'm going to answer in your next question, no one is not saying not to do an RFQ because you know what Councilperson Dreher I actually really agree with you. I'd like to see what's out there. We have a real opportunity to go out there and see what other firms may be out there in the next week and do it, but one of the things that discussed at admin and finance is, number one, we need to have somebody appointed and right away.

Secondly, I think that for the first 30 days, those contracts that I believe needs to get done before we get sued because we are really way stretching ourselves with contracts that are not signed that fortunately, we have very good relationships with the PBA, with **[unintelligible 00:40:49]** with Pennoni and waste management that we don't have agreed signed contracts that they could easily just come out and say, "We're not practicing good government and technically, we're really on odd." To answer your question about the financials, and they're right here if you would like a copy, I specifically asked Erwin to get this before the meeting today.

We are trending in a way where it's not too far stretched to what the interim attorney would be requesting as far as where we have been at. Then to the question before the moneys was, you're right, we have to be transparent. We didn't do with the manager. We have an interim and now she's actually next on the agenda with what we're going to do. That's the next item as far as what we're going to discuss, but I do agree. I think we do need to have one, but please understand that an RFQ doesn't happen overnight. It's just 30 to 60-day process.

We cannot be without an attorney for 30 to 60 days. This contract does not say he's going to be with us forever. It does not say he's with us for a year, for two or three, it says that he's willing to be the attorney of record and while we decide whatever we are going to decide as we move forward, which would be what you're talking about, which is what we talked about at admin and finance and we talked at the March Council meeting, which would be, once we are caught up with the four or five areas of what we need to be, then we are able to potentially, if the council so pleases that way, then and RFQ actually has to be written out and handled, then it moves forward then that's how the whole process starts, but we can't just do an RFQ and not an attorney in place.

Werner Dreher: With all due respect Madam Mayor, you still haven't answered that question why are we raising the salary from \$4,000 to \$8,000?

Claudia Cubillos: I just answered it Councilperson Dreher.

Werner Dreher: It wasn't clear to me, I'm sorry.

Claudia Cubillos: Okay. I'm going to be even more clear. When attorney Geller charges 1,500, it wasn't all-inclusive, which is why we ended up paying last year 74,000. What contract, if you all read it, it is all inclusive. There's not going to be land use fees, there's not going to be when we pick up the phone and there's a fee for that. This is all inclusive. When you add up what we've paid Greenspoon to what we're being asked to pay now, the difference is a little bit more, yes. Would you like me to say this year? We're making it perhaps- what is that called a month?

It's going to be the same every month, but guess the better to that point is, we actually know what we are going to pay in. Erwin brought something to my attention today. There's a bill for \$34,000 in Greenspoon that hasn't been paid yet. The reason it hasn't been paid is because I signed checks and I questioned everything. I took that bill to Tallahassee with me. Erwin asked me before the meeting, "Ms Mayor, what are we going to do about this bill?" I said, "Clearly, the attorney told me that he was going to bring it down a little bit and that we will have to pay a portion of it because we have to do what's right,"

But there were many many many bills when Jo Geller was a little busy and we had Alicia Luis and we had Steven Weary and so on and so forth. The bill is still going to be a chunk of change, but the only thing he's going to change, which I think is customary in most municipalities, the attorney's charge to be 5400, but for municipalities, they charge 200, which is what these attorney is charging us as well. He was just going to take that bill and, I think, look at all the hourly rates and I think like Alicia and the other attorney were charging us 350 375. He says no, he will never approve that so we're still going to pay a bill.

Keep in mind that we may have paid 74, but there's still a \$34,000 bill that- 34, 26 [unintelligible 00:44:55] that still needs to be paid. Figure if we take a little bit off, it might be maybe 29,000 if we take a little bit off, but it's still a bill that's going to get paid.

Paul: If you look at the budget and you take the legal retainer and add the other legal, it comes to 85,000. What you're proposing now is 96 so it's \$11,000 difference. However, the big difference is that if there's any lawsuits which the village has to address, it's all going to be all-inclusive in the fee. It's not going to be on the extra charges because that's, as you know, we've had a couple of years we've had one or two lawsuits and we had that one workers complain where our cost in legal fees was over \$50,000. You have to bear that in mind also.

Claudia Cubillos: Did I answer your question?

Werner Dreher: No. Honestly because I'll be very honest. First, now I hear an \$85,000 figure and \$96,000 figure, then I see in the contract the four \$8,000 increase in figure. That's my take and no disrespect on your recommendation or anything. I just don't have that level of comfort right now to make an informed decision so that's my take on things.

Claudia Cubillos: No. I'm just going to reiterate and I pose. I didn't mean to sit you down, but I've just got to be public comments and that public comments right now. I'll reiterate it just one more time. I would believe it's better to know what we're going to pay so it can be properly allocated as opposed to what we have been doing for the last couple of years, which we just say 18,000 is retainer because 15 times 12 is 18,000 a year, 1500 which is as retainer to come to the meetings, one meeting. It's 1500 then everything else is added on, as opposed to knowing that this is what the fee is. As you can see, there's many many many bills that came in that was not budgeted for.

That was the biggest eyeopener for me last year and I believe most of the invoices went through the clerk because I think Erwin sent them to the clerk and the clerk had to forward them to me, then we sent them to Jo Geller. That was just one bill, but there was a total of, at least, five to seven bills that I had to-- excuse me, invoices that I had to question because they were definitely steep. Clearly, what we have to monitor is if this is the route we're going to go for 30 60 90 days that there is nothing charged over that because this is a set fee that we know and that we can budget for that accordingly.

Werner Dreher: One more question too, I checked my emails and I want to make sure, has there been a resume out there distributed to us just to see what the education experience have we collected a pool of perhaps resumes out there? It's specific right now with the law firm as well. Do we have any resume out there?

I came in prepared at the January February and I would have come prepared today, with the resume of an attorney that I want to recommend because we must have an attorney before we do an RFQ, which again, we all agreed with you at the last council meeting.

Again, when you have a meeting we read the minutes and we look at the audio. We all agree with you because this is a real opportunity for us, but we didn't have anybody and the council had voted to remove Greenspoon.

Werner Dreher: Those are where my level of comfort decreases because I don't have a resume in front. I haven't seen a resume out there. A person who works like a regular Jo out there, anywhere I go for an interview or I'm considered for a position, I want to see a resume. At least you get an idea of the qualifications for that person. If I don't have a resume out there, I've just checked my email right now, I haven't seen a resume out there. Put on my position, what's your comfort level of moving forward with the contract?

Claudia Cubillos: I'm going to say one thing and I sincerely don't want to disrespect you in any way, I don't, because I do believe we are all really busy, but I've been a councilor for a few years now and if the mayor or the council, and I missed a meeting, had said that they were going to potentially appoint or recommend an attorney, I would immediately called the clerk and ask for one, if she had one. I would have googled the individual. Usually, most attorneys, you can google and you can find them. That's what I would have done, but I'm a little more proactive and that's just who I am. I apologize, I don't know why.

Norman Powell: I can synthesize the conversation and give you at least a legal opinion. First of all, Florida law doesn't require any particular process to appoint attorney. An attorney that represents the council serves after one of the council. I could present an agreement or any lawyer could present an agreement that specifies any period of duration. It's month-to-month. It's at the will of the Commission. But I hear what you're saying, to the extent that it's the will of the Commission to go out for an RFP, RFQ. That process still has to take place with some gestation period.

You're going to have to pick some it at some point in time, but you still have to have someone in place, to the extent that I've never met anyone up here before. My only experience with the dais has been at the League of Cities. I've met Mr. Mathis before contrary to the comments. I've met with Mayor Cubillos. In fact, my assistant personally called each of you or we didn't email because that we find that to be a little bit formal. We may resort to email after we can't get a phone call back, but it's public record, so it doesn't really make that much difference. We tried to reach everyone.

What's important here is it's not about us. It's about the residents. I've only been quote-unquote, appointed interim since the last committee meeting. Since then, we can participate in the negotiation of the police contract. We're putting together the waste management agreement. We're looking at the scepter to sewer issue. We're looking already at the proposal to develop the vacant church site. I just got, a few minutes ago, a subpoena-- actually, a motion to hold the village in contempt for a subpoena that was issued that was ignored. You're more than welcome to decide to go on a hiatus, but the business of the village has to go forward in some deliberative process.

It has to be handled in a matter that's competent. Now, to the extent that, if there's any concern about my qualifications, you're barking up the wrong tree. I don't think there's anybody more qualified in South Florida to do this job, but you can research that for yourself. More importantly, when I was asked to propose an agreement, one of the things that I did purposely because of the nature and size of this village is and it's no secret the millage here is not dependent on much commercial revenue, primarily right now based upon the taxes that the residents paid based upon **[unintelligible 00:53:36]**

I tried to put together what I thought in the interim basis an agreement that would not be upside friendly to my law firm. I basically looked at all of the areas of governmental work that would be required by the village. It's itemizing the agreement, If you take your time to

look at it, you'd see that I've covered every area that I believe the village is going to need, at least in an interim basis. Now, to your point about soliciting other attorneys, that is a will of the Commission. I'll be certainly more than happy to participate in that process, but I can tell you, from experience over the last 28 years in doing this, that the larger firms are going to be beating down their door to come and invest the amount of time to get the work done for the village.

Why I'm actually now appointed to North Bay village is because they had the **[unintelligible 00:54:32]** They had the Greenberg Traurig and the bills approximated over a million dollars a year because they were being billed for everything. What you need, and it doesn't necessarily have to be me, this is just advice. What you need is somebody who's willing to go all-in, somebody returned your calls, somebody who wants to sit with you and understands the direction, the policy that you're trying to implement on behalf of the villages residents.

If you don't have someone's gonna pick up their phone and return it, you can pull everyone here since I've been here and then I got a respond to call or responsiveness. That's what you need. It doesn't have to be me. But when you put that RFP together, you must make sure that you keep that in mind because you're going to be in the pecking order of a bigger firm or a firm that's doing this for a lot of villages. It can't be happening if you're going do it the right way. Based upon the testimony we've heard just today, it hasn't been all-in for whatever reason. I've known Jo for years. I've represented Jo when he was in the Florida Senate and his brother.

If you look at my experiences, I've represented the Florida Senate, Democratic Party, North Miami, North Bay Village, just about all the municipalities around here, including Miami Shores and North Miami. I don't think that experience is an issue. I think what you have to decide is what are you going to do at the end of the day. I have no problems in month-to-month because I was asked to come in on an interim basis. You've got a lot of work to be done and I think that's what we need to start doing. If at the end of the day, you want put a switch it or in, that's your choice. But your charter requires that you have an attorney.

Your charter requires that you are responsive to the needs of the residents. I serve at the pleasure of the Commission just like the manager. I could give you an agreement for 20,000 years. You can come back with the majority and I'm gone. That's all I have to say on that. If you need an explanation about the building, I'd be more than happy to give that publicly because that's what's important here. If you look at the agreement, you'll see that I've

Werner Dreher: Just so that I'm clear. Norman, at no point. I'm questioning your qualifications like you stated, I'm just asking for a resume.

I'm excited about that as far as I'm having that. I want to hear what the council has to say. Councilperson Dreher who not on the committee, Vice Mayor Nickerson and Councilperson Mathis, if you would like to as well before there maybe a recommendation or maybe not.

believe that with all the construction of Biscayne Boulevard 995, that it is time that perhaps we revisit doing a a common study. We did it about-- I want to say like-

Harold Mathis: Five years ago.

Claudia Cubillos: - five, six, seven years ago and we didn't qualify. If we qualify for traffic common study, what that means is one of two things potentially. Number one, speed bumps can be put in placed, and number two, they may reduce the speed village wide. Speeding, again, is something that comes and it goes, comes and in goes, but it doesn't really go anywhere.

I know the residents want our police officers everywhere, but when you only have one or two on duty per shift and two is scarce on shift, they can be in this small village at the same place at the same time, which is 87th Street, which is Worthwest Second Avenue, which is 90th Street, 86th Street, Cherry Forest, Northwest Second. It's really, really difficult for them to be all at the same time in the same place.

We are hoping that maybe if the council makes a motion, and all of this is really going to do is give a directive to the manager to go ahead and open that conversation with the county to start the dialogue about a traffic study. The next component is residents have been emailing me because they want to start putting signs out. I've tried to tell the residents that we could put all the signs, Ducks Walking, Peacocks Walking, Kids Are Playing, but the police officers can't afforce the sign in this village unless it's county-issued. With that said, while the signs are really cute and pretty and some of them have been putting them up on Northeast 87th, I think our end goal is to really reduce speeding and save lives because, again, you have dogs and you have children that are walking on sidewalks, and a lot of our streets don't have sidewalks.

I ask the council that we can have a dialogue. All this is really d-- If this motion were to pass or if there is even a motion, is really for the manager to entertain a conversation with the county so we can start the dialogue and get the wheels rolling. This is nothing that's going to happen right away. Everything takes time. This is something we will have the budget for the new fiscal year because the traffic study is going to cost anywhere from 20,000 to 25,000. I know this is music to your ears one because you're thinking of traffic calming patterns or maybe swales and things like that. With that said, any questions from the council on this item?

Richard Pinski: Madam Mayor, Council Richard Pinski Acreman. I think I went to the bathroom at the wrong time because I think there was a discussion about money for a traffic study, what not. When I heard money-- and I know the manager knows this, congratulations by the way madam manager, that you have the MPO which has funds available for just this. The federal government has just passed- the President has signed the \$1.5 trillion infrastructure package, that they'll have basically nine months to spend, so it's going to come very quickly. I have ATVs and motorbikes that come zooming through and turn on 87th heading towards North Miami to go around through Little Haiti.

It's a constant battle. Sometimes the police officers are scared because it is two sides of the village, but it does feel like the West side get forgotten in that aspect. I know on incorporated Davis across the street and I am the last block of El Portal that in the last corner of El Portal because we're on the coldest sec at the end. People get lost all the time because it's a dead end and nobody realizes, so they come through trying to find a way out, they don't realize there is now way out, but the speeding is a really big issue on that corner.

The one caveat that I'd present, the term of the agreement is that, because I evaluate the interest rates for any moneys that have to be borrowed on the project, those interest rates get adjusted quarterly, so the one thing that this is time-sensitive with respect to the interest rate is defined in there. It's 1. -- I'm going off-memory here. It's 1.16% or something like that for the planning part of the project. As long as the village executes that agreement by April 1st, it locks in that interest rate.

Steve Lyes: From our standing point, from a project timeline keeping things moving, and I'm not a hundred percent positive of this, I would just say as gut feel, trying to secure an approval within two months, would be the goal, but I have a feeling some of these terms that can be negotiated in here, dollars and contribution and this sort of stuff, I have a feeling if the village proposes a change it's going to take 10 attorneys on their end to evaluate it with their technical staff. It's going to take time going back and forth. I would not let it sit around, but anyway.

Attorney: If I may madam chair, I think we need to be really deliberate. I'm obviously going to take the six months, but I think the instructions should be to review it, come back within at least the next three months to get it done, that way I can work with the consultant, they can identify areas where we can actually negotiate it. There's also legal opinion that I noticed that they called for and hear that we've to put together so I think rushing in would be a detriment to the village.

The first question I have is- I don't know if you wanted to say anything because I know that we also talked about this, but just because I don't have it in front of me. Can you reiterate so this this? But when we spoke last when we had a committee, the Public Works Committee. We're talking about \$10,000, the scope was pretty much discuss from that time we had the Public Works Committee. How may I get to where we at? Why are we reducing the scope? I know we want to obviously reduce the \$10,000 to \$6,000 that's clear, but where did that come out of?

I know a councilman Mathis that is beavering up the question though, but is it really reducing the scope are we truly going to be getting that through aid that we're looking forward to help our residents connect to that sewer system? I just want to understand before why this change now. Besides, I understood because you got council Mathis. He did mention about seeing the potential to reduce, but I want to understand more what's being removed from the scope? Perhaps, you can help me up--

Steve Lyes: Let me explain. He can find it in here. Originally, we went back to them and said the two grants. The one that we knew about which is the section 319. The deadline has passed. Let's take that out of there because you're not going to do this fiscal year. Why are we going to get you under contract for something that you're not even going to do until next fiscal year? The other grant is not- we're not talking about that right now. We're just doing one grant and we're doing the negotiation for WASA.

What was taken out was that other grant and assistance in helping us and helping the village become a utility which you have decided you do not want to take that responsibility on. Those pieces have been taken out. Now, we're getting to really what we need which is negotiating with WASA to reduce the amount that we're going to paying connection charges and applying for funding so that residents can have a way to fund those connection charges. Those are the only two crucial pieces on this proposal. It's in for the record, I'm sorry it's \$6,300. To be perfectly--

Attorney: Yes Madam Mayor. An ordinance of the village of El Portal Florida amending the code of ordinances chapter five, appendix permit fee schedules only fees in order to amend the zoning fees, providing for incorporation of recitals, providing for conflict and repeal, providing for severability, providing for codification, providing an effective date.

Claudia Cubillos: Excellent. Thank you so much. I want to bring up Juan at this time and Camilla to please talk a little bit more about this and I want to remind or inform the council that from the first reading to the second reading, there has been a change and I just want to be sure that Juan recognizes that. As a reminder, when this was first passed, we gave 60 days instead of 30 days because we wanted the opportunity to have a town hall, which we did.

At that town hall we had a few, usually a lot of residents, but one resident pointed out what would be, I don't want to say an era, but something that could be placed better, or look better, or made more sense, better's a better word. As a result, or has it changed to this second reading and I want Juan to please let the council know exactly what that changes before we move forward.

Juan Muirati: Certainly Juan Muirati, planning and zoning, preservative design. The major change that we did was really formatting. The biggest one was the formatting. We separated Z3 from Z4 and Z5. That is single family residences from everything else, for both clarity and so that residents know exactly what it is that they would be paying. We also reduced the fee for something that we have introduced, which is called site improvements.

It makes complete sense. There is some confusion in the code with regards to what a site plan approval is. It's a process by which is required before certain applications, site improvements would be anything from a new pool or a fence, and that doesn't require a site plan approval. We've created a separate category for it, which is comparable to the average that we found in the seven municipalities that we're comparing this to.

The average is 270. What we've recommended is 300, that's pretty much it. That's pretty much the changes that we've done from the first reading to the second reading. I'll just remind you that these fees have not been changed since 1965. I found out, I did a little bit of

Richard Pinski: For the record, Richard Pinski, Acreman, and Kevin Cabrera Southern Strategy Group.

Elon Notelas: Elon Notelas, Notelas and Roberts Group.

Richard Pinski: Mayor, Council, Madam Manager, Mr. City Attorney congratulations to you. We wanted to come in the first meeting following this session. We felt it was important because not only was the session itself, every session is unusual and different and this was no exception. This session was different for a lot of reasons. Indeed, what was going on normal, as normal could be, we thought the hurricane was going to be the big issue, the big budget issue, it turned out to be the horrific tragedy of February 14, completely transformed the end of the session.

The budget had to make room for certain items at the end particularly in Medicaid. There is a huge fight on safety net hospitals. There's a lot of food fight going on in the budget. One of those things was school safety. We had a bad year as far as number of bills go. Last year was the record fewest number of bills ever passed in the 2017 sessions. Only 300 bills out of the

1,600 or 1,700 bills that got filed. This year, out of the 1,600 or 1,750 bills, only 200 Bills passed. The budget was unusual and that was not the usual process for water projects.

El Portal, we thought everything was going according to what you had to do, in fact, representative Harman got the bill heard in committee which was only 15% of all the project bills. Not all of them got a committee hearing, very few. We were fortunate to get one of those. We thought that was really going to set it up because not everybody made it in.

The Senate did not have a deadline. In fact, everyone was waiting for Senate Bill deadline of projects. It was just announced three weeks out, that's it, budget is done without a single hearing or pin dropping, nothing. There was no opportunity to say, "Oh." To scramble at the end.

The process was unusual in that way, and, of course, unfortunately, El Portal was not able to follow up on the rest of the funding that we got from last year. There is only, last year, there's \$55 million in water projects. This year it ended up only at \$30 million. There were very few projects that made it. Full disclosure, I also do work on behalf of Miami-Dade County. I represent WASD public works department. I work on their water projects in Tallahassee as well. They got zero. County got nothing. It was a bad year all the way around and didn't end the way that we wanted.

On a positive note, we really do think there is a lot of things in the budget that now, and we are all happy to work with the city, with the village manager because there are parts of money that were untouched in the budget. A lot of times, as you know, Madam Mayor, there is provisor language. A lot of those pots of money, the provisor did not sweep all of that money, so there is still pots of money available for whether there are transportation issues, certainly cultural grants, there is money available. We talked about some of the infrastructure money under plans items.

We're happy to continue to work, pick up and, of course, get ready for the next session, but sounds like there's a lot of things going on already that perhaps we can help find some things that would supplement it. I did bring by the way, and I'm very quietly going to hand this out, this is just an overall, so you'll have a good reference of things that just passed in general and didn't pass, so you get a good feel of session. There's a lot more on here that failed and passed, but I'll introduce Kevin from the Southern to follow along.

Kevin Cabrera: Thanks. Speaking of the pots of money, one of the ones that was funded again this year was Governor Scott's job and growth and infrastructure fund about 85 million. It's a fund that sometimes doesn't get a lot of attention. It started last year and, basically, it gives the governor almost sole discretion in deciding how to allocate those \$85 million dollars. Cities apply, municipalities, districts all sorts of entities, and everybody's eligible. There's not necessarily a set criteria. Their number one component that the governor does look for is the ROI for the state and what's going to produce jobs which has always been his number one priority for the State of Florida.

I think that that's a large, as Pinski was saying, a large pot of money that's out there, 85 million. I think, correct me if I'm wrong, I don't believe that last years 85 million has been completely--

Richard Pinski: There's 30 million out there.

Kevin Cabrera: There's still 30 million, so now we've got 85 plus another 35 that the governor has at his discretion to allocate, and being that his term is coming to an end soon in a couple of months, I'd feel that he's probably going to allocate all of it out [laughs] in a relatively short manner. I'll turn it over to you, Adam.

Adam: Mayor and Council, not to be longwinded, my colleagues has covered all the points. I would also add your representatives wanted to come tonight, both Representative Harman and Senator Daphne Campbell. Though we're not in the agenda, last we should mention we felt the need to actually come since this was the first meeting after session, but this is ongoing discussion with not only the mayor and the council and also the city manager as well to discuss these opportunities as we move forward before the start of next session.

Claudia Cubillos: Thank you. I want to thank you for your time. I have the opportunity to really dialogue a lot with you, I spent some time with you in Tallahassee. I wanted to open it up to the council that perhaps hasn't had the same, so Councilperson Dreher, any comments?

Even with the hurricane, there was going to be a lot more emphasis on the water projects, but, unfortunately, the Parkland situation, tragedy, caused them to allocate \$450 million to school safety and uphardening of schools and to have more resource officers and so on. We know that El Portal does have a school within its boundaries which should benefit from the school safety and having additional resources available to that school through the school district.

Claudia Cubillos: I know. When you all sent the email, the manager, the chief, and I replied almost immediately with whatever we could as part of what we will need for the school, so thank you. Councilperson Dreher?

Werner Dreher: I've got a quick question here. I'm looking at the Florida legislative newsletter 2018 what? Passed and failed, right? Looking at it from a public works perspective, I'm just skimming through this. It's the first time I'm seeing this. Could you give us a quick update? I know last time you guys were here, we brought in a couple of items to bring up to Tallahassee. I know Councilwoman Vimari and our mayor have been up there. They've been advocating, so I just want to hear from your perspective on the especially the septic to sewer, one phase. I know we had that 20% piece that the village we'll have to put up upfront. Looking at this report here, I don't see anything in that respect.

Perhaps you have any updates on what we talked the last time you guys were here.

Richard Pinski: Sure. The intent was we had two projects that we were going to be requesting. One was to build on the \$550,000 that we were able to help secure in 2017 session, so we're going to come back with the rest of the storm water discharge flooding areas in addition to the [unintelligible 03:00:57]. That was one project. The other was trying to convert as many septic to sewer as we possibly could. We designed that project in concert with what we thought Pennoni was going to be doing which was they want to see regional impact.

Connecting on 2nd Avenue was going to be the natural, so we had that project in as the overall connection because we were one of the few remaining on 2nd Avenue not connected as well as the flooding from the stormwater.

Werner Dreher: 2nd Avenue is Phase Two supposedly, but more focused on the Phase One, that's on the west side which we had, I don't know if you guys heard, but 2019 as it dates.

Richard Pinski: Correct. Part of that was directing towards what DEP was offering already as a revolving loan. We like going for free money. [laughs] The project, that Phase Two is the one that actually got heard in committee, so at the end, we had to choose because there's almost 1,000, it was about 1,000 bills totaling \$2.1 billion. In addition to the 1,700 bills that were introduced over substantive legislation, there was another thousand house bills worth \$2.1 billion just on water projects. Trying to compete for a hearing, so we got that one bill heard and we thought that was the one we were gonna push forward.

Werner Dreher: On Phase Two, yes?

Richard Pinski: As far as overall and that's what we mentioned, that's what Kevin was saying earlier was of the 25 to 30 million of what they were calling water projects, there was maybe seven actual septic to sewer in the entire State of Florida. We, unfortunate, were not one of them. While that started out, as Kevin said, that started out as one of the priorities. The 400 million, the rumor in conference committee was that 400 million that was going to be pledged, was going to wipe out all water projects. For a while there, we had about a 48-hour period that we thought not a single water project was going to get done, and really when that budget got printed, it was like everybody's looking at it for the first time.

Infrastructure projects all overall got hurt by everybody.

Werner Dreher: The base one is what I'm talking about.

Richard Pinski: That's for Hajj, but the flooding project that we got last year, that's still continuing and we want to come back, of course, next year and do it.

Werner Dreher: For next year, that will be the 2019 legislative, that's what you're saying.

Richard Pinski: Correct.

Kevin Cabrera: Another thing that were noted earlier is that the governor does have, at his discretion, some 85 million this year plus 30 left over from last year for infrastructure projects that he deems are of merit and that they have regional impact and state impact. That's a grant that would be worth pursuing on behalf of the village especially as soon as possible as we get nearer toward the end of his term.

Richard Pinski: There's no deadline on that.

Kevin Cabrera: There's no deadline to apply, there's no deadline for him to allocate it. It's solely at his discretion.

Werner Dreher: What's the name of the grant?

Kevin Cabrera: It's the Florida Job Growth and Economic Development Fund. We don't have to wait until 2019. It's money that's already available. It's at the governor's discretion you apply. There's an application process you apply and the governor staff and himself they evaluate each project on its merits and they decide which ones they feel have a regional and state impact.

Werner Dreher: Is that something we, and I'm just asking questions on that, is that something we can apply then for the Phase One? That indicates that the Phase One septic to sewer it's about 4.4 million we're assuming. I see a nodding head over there in the back, but I just want to make sure this grant that you're talking about perhaps we can apply for it, but I'll let you guys answer that.

Kevin Cabrera: I'd say that the one on 2nd Avenue, I'm not sure which one of the phases that one is, that would probably be our best bet.

Richard Pinski: Probably second.

Claudia Cubillos: That's just because, I would just reiterate, isn't that because one of the biggest things the governor always focuses on is ROI which is return on investment? They want a regional impact and they're not going to get a return on the investment if it's on a residential area. It would have to be a business area that could be potential business area that's going to develop jobs and create jobs, and it's going to be an economic advantage to the town.

Kevin Cabrera: Exactly and the argument is you're going to pay taxes to the state. State tax is going to be generated. That would be the argument to be made for that project. Unfortunately, a residential area you wouldn't be able to make that same argument towards the governor. That's his criteria. It's at his discretion, unfortunately.

Claudia Cubillos: The the win-win on that not only that, I would assume from the governor's perspective is not only the return on the investment, but Northeast 2nd has a regional impact. It doesn't just impact the village of El Portal, it connects to Miami Shores, it connects to Biscayne Park, it connects to Little River, and it connects to Little Haiti. That's the regional impact that we're looking for.

Richard Pinski: [crosstalk] including the sanctuary, the project because that's the job component, and you could do something for little farm, infrastructure. These are all ideas. What Kevin was saying earlier was they did a new 85, that's what just came out the budget. We'll still have 25 or 30 left over that we haven't spent already plus a new 85. Now he's running for US Senate and there's no reason why he would leave any money on the table.

Kevin Cabrera: For the next governor.

Richard Pinski: It's all going to go out the door.

Werner Dreher: Quick question then to Kevin's point. I know we're working on Phase One, but is it too premature to apply for Phase Two now that we have this opportunity?

We did a fund farewell to Mr. D last week. We had a wonderful retirement luncheon for him on Friday. Yesterday was his very last day, but he's retired from our ranks and moved on. We will have to find a part-timer or some staffing to fill in his public works responsibilities. We have identified a cleaning service that will be doing the internal cleaning here in the village hall and they will be starting on April 3rd so that's next Tuesday.

This week we've got to clean up after ourselves. [laughs] Be as clean as you can. Hurricane Irma, we're still working with our contractor, but just of note, the Mayor's Town Hall Series April meeting will be the emergency preparedness townhall, but the second hour, it's a two-parter it's going to be the public safety, aggressive driving townhall where we'll talk about the speeding, and what we're doing to address the speeding. Hufnagel to try to do something for enforcement for the village and so we're getting all of that.

Then, as well as the emergency preparedness guide and handbook and instructions, hopefully, we'll have all that finished by then, but it's my target and I think we'll have it completed so that the village is on same page when it comes to responding to emergency situations. We are addressing the speeding and aggressive driving slowly, but surely we're getting there. We hope to employ a decoy vehicle somewhere so that that can perhaps deter the speeding. We've gotten our speed guns recalibrated or calibrated, so they will be used soon. We just have to work with the limited staff. We are trying to identify creative ways to staff and get police officers.

Let's see. Thank you. I'm skipping around a little bit just because I think either way. We do have a new building permit clerk her name is Daisy Haifa. She is being trained right now by the cap government staff and we will be renegotiating the whole presence there at the front desk. That's a building permitting clerk and in the past, that position was a Cap employee. The last person who held the position was Elena Grec, but she's no longer with us. I'm going through the cost-effectiveness of having that position as our own employee or would it just be more effective to continue that relationship with Cap.

There are some things I need to review with Irwin in terms of the financials, but for now, that's what we have but we are working on resolving that. Let's see, I will be working with the attorney on some outstanding items that trickled down from the former village attorney. That's the public works right-of-way permits variants after the fact a land conveyance with Mr. Hugh Gladwyne. Those are items that will be worked on and hopefully, we can move those along quickly and move on to other things. We are out of compliance with two major contracts, but I'm working on those daily.

One is the bus shelter on Northeast, 2nd Avenue, and the other is the National Pollutant Discharge Elimination System MS4 permit. We're trying to get there. We have deadlines, we're out of compliance and I was told we haven't filed reports since 2011. I've got to go back and try to resolve all of that. I have asked Robert Romano to take on another responsibilities with project management and working with me to get those technical details prepared for the reports that I have to submit. All of this is due by June 30th. It will be a quick project. That concludes my report.

Christia: Exactly, right. In fact, they had a compliance meeting via telephone versus FDP yesterday with I have to deliver by a certain date. That's why I called him one on one because I need help with that. I can't do the other things or do the thing business of the village and get all of this information. If we don't abide by this new deadline, this set deadlines, we will be fined \$10,000 a day and we still have to do the work, but there is no way out of it.

with plans and I had a town hall on that in January. They're showing us the plans of what their intent is and it is up to us to approve it, but that is where we have to do our homework.

Werner Dreher: What's the expectation from the council? to review those plans and make recommendations?

Claudia Cubillos: Your expectations is to know what's going on and if you have a doubt, ask. I'm sure I've looked at it, I'm going to have doubts, I have questions. We want to be sure that whatever goes in the sanctuary is the will of the residents. We want to be sure that whatever goes in there is by a form-based code. We want to be sure that whatever goes in there is the vision of the residents. The visions of the residents don't want to see a big change story, they want to see art studios, they want to see a nice local restaurant. That's based on the charade and based on a form-based code.

That's where we have to do our due diligence to look at it and say, "Is this the will of the residence? Is this what we want to see happen?", but that's where it's really important for you to call the attorney. It's really important for you to call if you have questions, but you have to first take a look at the plans and become familiar with what it is and then move forward with any questions, comments or recommendations. Or you might say, "Wow, this looks amazing. I can totally see this to be in the village of El Portal. It goes along with who we are, what we are, and what we plan on being.

Norman Powell: I think if I can just clarify what they developer, and this is just general based upon my baptism this past three weeks, the developer is going to come with a site plan for approval, and included in that are going to be necessarily use exceptions, especially use exceptions which require covariance's, which require council approval.
