RESOLUTION NO.: 2018-13—

A RESOLUTION OF THE EL PORTAL, FLORIDA VILLAGE COUNCIL, APPROVING A THIRD EXTENSION TO THE STORMWATER UTILITY INTERLOCAL AGREEMENT BETWEEN THE VILLAGE OF EL PORTAL AND MIAMI-DADE COUNTY.

WHEREAS, on May 5, 2003, the Village of El Portal Village and Miami-Dade County Storm Water Utility entered into a Interlocal Agreement ("Agreement") to continue relationships and responsibilities to carry out functions of the Miami-Dade County Stormwater Utility within the geographic boundary of the Village of El Portal, as set forth in Article V of Chapter 24 of the Code of Miami-Dade County; and

WHEREAS, the initial five (5) year term of the Agreement ended on May 4, 2008, and WHEREAS, the Agreement may be extended for five (5) additional terms of five (5) years each; and

WHEREAS, the first five (5) year extension of the Agreement expired May 4, 2013, and WHEREAS, the second five (5) will expire May 4, 2018;

NOW, THEREFORE, BE IT ORDAINED BY THE EL PORTAL VILLAGE COUNCIL;

Section 1. Recitals. The foregoing recitals are true and correct and are hereby incorporated herein.

Section 2. Approving Third Extension. The Village hereby approves the Third Extension of the Stormwater Utility Interlocal Agreement between the Village of El Portal and the Miami-Dade County Stormwater Utility, executed on May 5, 2003 for a term of five (5) years through and including May 4, 2023. The parties agree that the Third Extension to the Agreement shall be effective as of May 5, 2018 and that all other terms and conditions of the Agreement shall remain in full force and effect and unchanged.

Section 3. This Resolution shall become effective immediately Effective Date. upon passage and publication as required by law.
