A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, TO APPROVE AWARD FOR REQUEST FOR PROPOSAL (RFP) RFP# 2017-02 VILLAGE OF EL PORTAL TO DISASTER PROGRAM & OPERATIONS, INC., FOR DISASTER DEBRIS MONITORING AND DISASTER MANAGEMENT AND RECOVERY SERVICES; PROVIDING FOR AN INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, FEMA requires that public entities seeking to recover costs for debris removal resulting from a hurricane or other disaster have in place a contract for debris monitoring; and

WHEREAS, on November 1 2017, the Village of El Portal (“Village”) advertised Request for Production for Disaster Debris Monitoring, Disaster Management and Recovery Services RFP# 2017-02; and

WHEREAS, the Village of El Portal received one bid; the sole bidder was from Disaster Program & Operations, Inc.; a copy of the proposal is attached hereto as Exhibit A; and

WHEREAS, the Village Manager consulted with other jurisdictions as to the comparability of the sole bidder’s proposal and was assured that the price was competitive; and

WHEREAS, the Village Council of the Village of El Portal desires to approve award of RFP# 2017-02 Village of El Portal, for debris management services to Disaster Program & Operations, Inc.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are true and correct and are incorporated herein by this reference.


Section 2. The Village Council of the Village of El Portal hereby approves the award for RFP# 2017-02 Village of El Portal, to Disaster Program & Operations, Inc., for the Village Disaster Debris Monitoring and Disaster Management and Recovery Services; per the


