

**RESOLUTION NO.: 2018-10**

**A RESOLUTION OF THE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, ESTABLISHING A TAKE HOME VEHICLE POLICY AND PROCEDURES; PROVIDING FOR CONFLICTS; AND PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE. (INTRODUCED BY CHRISTIA ALOU, VILLAGE MANAGER)**

**WHEREAS**, the Village of El Portal is committed to enhancing public trust and to conforming to the standards of good government;

**WHEREAS**, as part of the ongoing efforts to provide for the good and welfare of the Village of El Portal's employees, the Council of the Village of El Portal continues to review, revisit, and revise its policies and procedures;

**WHEREAS**, the Village of El Portal Council has determined that the standards of good government require that the Council adopt a take home vehicle policy and procedures;

**WHEREAS**, the Village Council finds that these procedures are in the best interest of the Village of El Portal.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF EL PORTAL COUNCIL THAT THE ATTACHED TAKE HOME VEHICLE POLICY AND PROCEDURES IS HEREBY ADOPTED.**

If any word, clause, phrase, sentence, paragraph, or section of this Resolution is held to be invalid by a Court of competent jurisdiction, such declaration of invalidity shall not affect any other word, clause, phrase, sentence, paragraph, or section of this Resolution.

**Section 2.** Conflicts. Any resolutions or parts thereof found to be in conflict with any provision of this Resolution are hereby repealed.

**Section 3.** Effective Date. This Resolution shall take effect immediately upon its adoption.
