

RESOLUTION NO.: 2019-02

A RESOLUTION OF THE MAYOR AND EL PORTAL, FLORIDA VILLAGE COUNCIL, AWARDING REQUEST FOR PROPOSAL #VOEP 2019-01, "EMERGENCY DISASTER AND DEBRIS MANAGEMENT SERVICES," TO DISASTER PROGRAM & OPERATIONS, INC.; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE THE RELATED AGREEMENT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE VILLAGE IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AND EFFECTIVE DATE. (INTRODUCED BY VILLAGE MANAGER CHRISTIA ALOU)

WHEREAS, the Village of El Portal, Florida ("Village") advertised and published Request for Proposal #VOEP 2019-01, "Emergency Disaster and Debris Management Services" to be prepared for hurricane season in accordance with the Federal Emergency Management Agency guidelines and requirements; and

WHEREAS, the Village received one responsive proposal by the February 28, 2019 deadline from Disaster Program & Operations, Inc.; and

WHEREAS, the Council finds that it is in the best interest of the Village to approve the Professional Services Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND EL PORTAL, FLORIDA VILLAGE COUNCIL AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are true and correct and are hereby incorporated herein.




Section 4. Implementation. The Village Manager and Village Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.


