

RESOLUTION NO.: 2020-21

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE EL PORTAL, FLORIDA OF MIAMI-DADE COUNTY, FLORIDA, PROPOSING THE LEVYING OF AD VALOREM TAXES OF 8.3000 MILLS FOR THE VILLAGE OF EL PORTAL OF MIAMI-DADE COUNTY FOR FISCAL YEAR 2020-2021; NOTING THE ESTIMATED ROLLED BACK RATE AND PERCENT INCREASE; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village of El Portal, Florida, of Miami-Dade County, Florida, is required to hold two public hearing as required by Florida Statute 200.065; and

WHEREAS, the Village of El Portal, Florida, of Miami-Dade County, Florida, held a first public hearing on September 8, 2020, at 7:00 p.m.

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, AS FOLLOWS:

Section 1. The recitals set forth above are incorporated herein by reference.

Section 2. The Fiscal Year 2020-2021 proposed operating millage rate is 8.3000 mills.

Section 3. The proposed operating millage rate is 9.38% greater than the rolled back rate of 7.5882 mills.



Section 5. This Resolution shall become effective immediately upon adoption hereof on second reading.




