

RESOLUTION 2020 -22

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, OF MIAMI-DADE COUNTY, FLORIDA, TENTATIVELY ADOPTING THE RATE FOR SOLID WASTE AND RECYCLING SERVICES IN THE VILLAGE OF EL PORTAL; (AS INDICATED IN ATTACHMENT "A") IMPOSING SOLID WASTE AND RECYCLING ASSESSMENT FOR PROPERTY LOCATED WITHIN THE VILLAGE OF EL PORTAL FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2020; TENTATIVELY APPROVING THE RATE OF ASSESSMENT FOR THE BUDGET FOR FISCAL YEAR 2020-2021; AND DIRECTING THE VILLAGE MANAGER TO FORWARD A COPY OF THIS RESOLUTION TO THE MIAMI-DADE COUNTY PROPERTY APPRAISER OFFICE; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village of El Portal desires that Non-Ad Valorem Assessment for solid waste and recycling be printed on the TRIM notice sent out by the Miami-Dade Property Appraiser Office for fiscal year commencing on October 1, 2020; and

WHEREAS, the Mayor and Village Council of the Village of El Portal, met on July 28, 2020 at 7:00 p.m., to review and consider recommendations pertaining to the proposed Non-Ad Valorem Assessment Rate; and

WHEREAS, the Mayor and Village Council of the Village of El Portal now desire to notice the rate and date, place, and time of the public hearing for the annual solid waste assessment;

NOW, THEREFORE, BE IT RESOLVED THAT, BY THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA:

Section 1. The foregoing Recitals are true and correct and are incorporated herein by this reference.


Section 2. The rates on Attachment "A" for solid waste and recycling services are hereby tentatively approved by the Village Council.

Section 3. The Village Manager is authorized to provide the Miami Dade County Property Appraiser any information that they may require to notice the meeting and the proposed rate. The meeting is scheduled for September 8, 2020, at 7:00 p.m. at Village Hall, or virtually if still required by the Governor of the State of Florida.

Section 4. This resolution shall take effect immediately upon adoption.
