**WHEREAS**, the Village of El Portal, Florida of Miami-Dade County, Florida, is required to hold two public hearing as required by Florida Statute 200.065; and

**WHEREAS**, the Village of El Portal, Florida of Miami-Dade County, Florida, held a first public hearing on September 4<sup>th</sup> and a final public hearing on September 25<sup>th</sup> as required by Florida Statute 200.065; and
