**Glen:** Sure, this resolution 2018-06 the resolution of the village council of El Portal Florida authorizing the approval of the variance for a new 4 foot 0 inches half privacy wall and a gate as requested by Sofie Watsle providing for incorporation of recitals, providing for an effective date.

**Cubillos:** Okay, great, thank you. Can you please tell me your name again? If you can please come up and state your name and the company for the record and who you're representing and so on and so forth.

**Maurizio:** Good evening, my name is Maurizio Zalza address is 618 Northeast 195 Terrace, Miami Florida 33179. I am the architect representing the homeowner Sofie Watsle and my firm is called Southole Design Lab and we're requesting this variance for a privacy wall.

We're replacing an existing privacy wall that is actually in the middle of a yard and we're requesting to push it to her property line, within her property line not encroaching into any right of ways. It's a 4 foot high wall. I appreciate the comment of our fellow neighbor here that the variance actually does, or should say 4 feet 0 inches as opposed to 4 inches 0 inches.

Again, we're just requesting this wall so she has more yard space in her backyard, and we've driven around and there are presently and examples in the neighborhood of in city of El Portal, village of El Portal I'm sorry, that have walls of similar height on the property line. We feel that it would be a respectful request. I'm happy I have a large set of drawings here, I'm happy to roll it out in front of you if that helps a little bit more and I can explain surveys or site plans of whatever is necessary having to explain.

**Maurizio:** Yes. We're keeping the same height, same style, the same gate.

**Maurizio:** That's pretty much it. Currently on her property line there is a roll of hedges which it's 7 feet tall hedges, now we're just going to have a 4 foot tall wall. I think visually it'll be a lot nicer and she gets better use of her yard as well.

the council to think about ways to make it less harsh moving it back 6'8 inches to allow and planting some greenery, something to soften it up would make it a lot nicer but there is precedence the other way.

**Cubillos:** Any other public comment please?

**Ward:** Dr. Lyford Ward 415 Northwest 80 Terrace. This is a masonry wall? What are you making it out of? What's it going to look like? What color is it? Is it raw masonry or is it pretty?

**Maurizio:** It will be painted, it will be finished in stucco to match the rest of the house and painted the same color as the rest of the house which we are, it's going to be white. Some sort of--

**Cubillos:** It's a solid wall.

**Maurizio:** Solid wall masonry. To address the gentleman's comment, we're happy to push it back 6'8 inches to add a little bit of landscape or greenery in front of the wall if that pleases the council, we're happy to do that.

**Ward:** I'm not objecting. I just have a problem when we start putting up walls that we might see graffiti and the court needs suggestion about plant where, we're going to be able to plant something there because we're going to have some problems, you're not that far off from the major terrace or so. Give it some thought.

I don't want-- I just know that that's just-- you've been here long enough to remember the graffiti on the school? When they got ready to raise the-- to do the fence on the park, nature trail, we did not want a wall because we knew about what the upkeep would be. We still need to have that fence done but I'm not objecting to it.

**Cubillos:** Thank you Doctor Ward. Any other comments from the public? Okay, hearing none I want to close the public, sorry. I want to close the public comments open it up back to the council to ask Maurizio if you have any questions with regards to this variance.

**Roman:** I do have a question if I may. Please remind me, this wall was with the original house?

**Maurizio:** Correct.

**Roman:** Correct? Right? What's the purpose of wanting to aside from having extra room because you just said that you're willing to push it back?

**Maurizio:** Well, right now it is back 13 feet into her property, so, she is losing about a third of her yard maybe even more to the street. She just wants to regain that. We would be happy to set it back a little bit, to have a little bit of green space we're happy to do that. Just 13 feet when her yard is 35 or 40 feet wide seems a lot of wasted space for her.

**Roman:** Does she live in the house?

**Maurizio:** She is going to move to the house once the renovation is done.

**Cubillos:** I have a question to the attorney because when this went before planning and zoning, I did not vote for it but it still made it here because you have just the three votes. The question I have to the attorney before any decision is made, is if you're willing to alter the plans in way to accommodate a recommendation that was made, wouldn't he have to redo somewhat in writing the description to what that's going to look like before we vote on it? Right now we're voting on actual plans that were submitted which is the 4 foot masonry wall that's going to go certain extent in front of the house?

**Nickerson:** Well, I think you can move to amend the proposed resolution to describe what he's agreeing to do, that's what you want and then he'll do his [sneeze] responsibility to bring in revised plans showing that he's complied with what you voted on.

**Maurizio:** Just a further elaborate on that subject. The plans are currently right now being reviewed by Miami-Dade County for the septic system. As soon as we're out of that which I expect to be this week, we're coming back into El Portal to address some comments that we have pending.

If the council recommends that we push the wall back 8 inches, then we would do this revision prior to submitting back to El Portal through addressing the comments, so, it would be part of the next revision which would happen in the next couple of weeks give or take. When it comes to the actual resolution, I don't know what the best legal way of doing that.

**Cubillos:** Yes, does the council have a recommendation based on reviewing the plans with regards to what we would prefer to see?

**Nickerson:** Yes, madam mayor, I would like to see the wall move back about 8 inches and to have greenery places between the wall and the sidewalk. Besides that, I have no other objection.

**Cubillos:** What does 8 inches look like? [crosstalk] that's shorter than a ruler?

**Maurizio:** Yes, actually on second thought I think probably a foot is a little bit more to give a little bit more soil for any planting, so, a foot. A foot would be a little bit longer than what's in this paper.

**Nickerson:** We can go a foot and a half. [crosstalk]

**Cubillos:** No, no, it's okay. Oh my God [laughs]

**Nickerson:** Too much.

**Cubillos:** [laughs] Does anybody want to make a recommendation and see if the architect wants to do something and we can amend the-- we can make a motion to amend the current resolution.

**Nickerson:** Yes, I'm just trying to picture as I'm walking past and I think that even the foot from walking past in foot, I would think a foot and a half maybe.

**Cubillos:** I don't think it's also the distance in front. I think the comments that were made also in the public which and it's unfortunate that our planning consultant is not here or a member of his team, is a masonry walls wall, right? They have some type of- what you would call it- I guess probability where not so hard, is that an option or is she stuck to the rock wall?

**Maurizio:** We could absolutely explore options, the house on the front side does have some what you would call a wing wall that extends out and they do have a couple of punched openings which we could mimic some of that. I wish I brought pictures of that with me. Maybe in the package, I think there may be an image of that front of the house.

**Roman:** I think there is but let's see.

**Maurizio:** We would be happy to consider that option as well. They have some, it's like a square 8 by 8 square along the walls, so, we could include some of that.

**Maurizio:** Correct.

**Roman:** Nicely [laughs] how is it going to attach to the house?

**Maurizio:** Now it's still attached to the house but on the front side and it's coming out from that existing wall that is on the front side. It's just extending that one and turning the corner along the western most property line.

**Roman:** It's hard to tell in this pictures but.

**Cubillos:** The existing wall that it has is 4 feet?

**Maurizio:** Yes, it may be 3, 10, or 4'2, somewhere

**Cubillos:** It looks a lot shorter than 4 feet, yes.

**Maurizio:** 4 feet is about this tall. Just not that much tall.

**Cubillos:** Okay. Are you saying it's just something like that?

**Maurizio:** Yes, correct yes something like that.

**Roman:** Like what?

**Maurizio:** I do would like to just--

**Mathis:** Just the punch out not the wall.

**Maurizio:** Yes, punch outs. If we're proposing to push the wall back 12 inches or a foot for conversation's sake and plant any sort of greenery, the greenery would most probably block those holes anyway. I think any permeability on a 4 foot wall just gets lost a little bit. It says in our architectural point, if the whole thing is landscaped to green, that could just be an option

**Maurizio:** It hides everything, it makes a lot softer green, I think that would be a good option.

not to mutilate his last name Rajkumar, who has joined our department. He was sworn in last Tuesday. I also want to thank Officer Santos. He was with us for three years but he has moved on out to the Florida Highway Patrol. One of the good things that we'd implemented in the last, probably, 10 months is that whether it's a full time or part time candidate for police officer, there's a panel now that they come before.

We implemented this in the spirit of keeping transparency in fairness to the process of hiring a police officer. As part-timers they generally have a first career already and this is just secondary. We want to hopefully track and keep them and have the opportunity to make them full-time in the event that there's something that present itself. There's a difference becoming a full-time and part-time.

We're into going a little bit about more in greater detail about tomorrow night. We covered evaluations, we covered staffs and schedules. Again, that is all going to be covered tomorrow night. It's a public safety meeting at 6:30. Also, Corporal Sharp, Chief and I, we sit on the ESAT board. I'm going to go a little bit more into that tomorrow because we have an ongoing issue with the marquees, we have an ongoing issue with our doggie bags and we have an ongoing issue with the trash.

At the first town hall the sanctuary for parties were here to present the plans to the residents, and they have now officially turned them in.

I believe the Council is going to get the packets tomorrow at the P&Z meeting. There is a lengthy internal process that involves building department, meeting with them, having questions and it's all of us so we have questions. This the time to really call them and ensure that it's what the vision of the residents want as it relates to those plans. When we get them, it's very exciting they turn them in, and they're pushing us and pushing us, but we want to be sure that we are following the proper procedure and we are reading the plans and looking it with a fine tooth comb.

If all goes according to our plan with the process, those plans that they submitted will go before the P&Z meeting in May. I talked about this in January but I want to remind the Council that at the January P&Z meeting Tishla Bice was here. They are a fiscal and economic planning analysis company. Where they come in or they are hired by a municipality that is going to be impacted by development. They will do an analysis based on who we are, what we have financially, what are our assets, and what the developments are going to look like, and how is it going to impact all of our departments.

This analysis is done with the hopes that we are little bit more aware of what that financial impact is going to be, so that when we are sited at the table with the developers that we're making or asking for legal recommendations that they can do as a partnership because they're coming into our city and clearly it's going to be an impact to our police department, our building department, our planning department, our clerk department, and our village manager and even the Council. It's really important that if the Council has not done so yet that they contact the manager with ideas as to what based on that analysis, what is a reasonable ask that we can ask.

of them that we really need to solidify is the medical marijuana dispensary ordinance, which has not been solidified. The second thing they were working on is the internal application process. It's really important that it doesn't matter who's here. We are all on the same page. We all know exactly what to do and we're not looking for the binder to read what we have to do. We know what we have to do. That's a part of our conversation that we have tomorrow.

In that sense, while we have them in public, we have internalized it and we've made note that there's things that we have to do to protect ourselves as well. In the event that anything should ever happen, we are all on the same side. It's an immense tragedy but we are hoping that everybody just does their part and does what's right. That concludes my report.

At this time, we have the manager's report.

**Christia:** Mayor, you covered a lot of the things I was going to cover but I'll just touch on a few things briefly. Yes, the developers of the sanctuary project officially filed their application on February 21st. That is proof that we're moving forward on that project. That's very exciting because I think everybody in the community is excited to see something happen with that property and something that's going to benefit the entire village.

The staff and I are coordinating with the mayor and council member Roman on the execution of our national Arbor Day celebration. We have been working pretty hard on just beautifying the village. In that, we have dismissed all our former landscaping contractors because we had four of them. We now have one. I have to tell you, they started last Tuesday. There's a lot. You can see the big change. One contractor handling everything from tree, maintenance, and clippings to taking care of the sprinklers. They finished the sprinklers today.

They do pressure washing so they'll clean the signs tomorrow. There's a lot that's happening. I'm happy to say that it has been a cost-benefit to us to reduce it down to one. We also know which company is doing the trees, which company is cutting the grass over here. We didn't know that before because we had to go through the list of all four. Sometimes they call you back, sometimes they don't. I think this is a good economy for the time and money for the village.

We're looking to do more enforcement and getting the word out. They will be partnering up with us to do outreach as well. We'll meet with them next week to start our part of that campaign.

Please know that we've put some things on the website. We've also been passing out cards about the relaunch of Drive Safe because, as we know, speeding is an issue. As people get off of High 95 and speed through our streets trying to get to this game or wherever they're trying to go. Yes, did you ever see two new vehicles for North Bay Village? I inspected one today. It looks really good. I didn't know it wasn't new [chuckles] but it looked really nice. I'm excited that our part-timers will now get their vehicles because our full-timers have the very new vehicles, but these part-time officers got the hand-me-downs.

Well, these are nice two vehicles that are more equipped and have the things we need to add our equipment into them. That's an exciting gift. We're happy to have that from North Bay Village. Yes, if anybody else wants to give us some cars, we'll take over. Acting chief, Huff Nigel, and her staff have been working hard on just improving systems. The chief actually attended a five-day seminar entitled, *Moving Up To Supervision*. She did that last month. That was a five-day seminar, so without her, but she came back with some good information that she'll be implementing.

Officer Botagli continues to work with the Miami-Dade Crime Watch Board. He's trying to implement some things here so residents are aware. He'll be working with us to get the word out for that. Other officers are taking more leadership roles as well. We're excited to see that and we're excited to see that our acting chief and the corporal are being more visible by doing career day panels and being active in the community. They've been taking Arctic out as well. That's nice that our Police dog gets a little sunshine, too.

Yes, we lost one officer, Officer Santos but we gained a fantastic new full-time officer, Vishwar Rajkumar. We're really excited about that. He has such a wealth of experience and maturity to add to our police force. I'm excited about seeing him on a regular basis as a full-time officer and he can teach our newer officers. But yes, we will be implementing more retention measures for our police officers as they come up through the ranks. We are still working with the PBA to negotiate that contract but it's coming to an end at some point, I promise you.

enforcement because I can't put everybody's business out there. **Courtney:** Mayor, when does this take effect?

**Cubillos:** I'm going to make a recommendation to appoint the interim attorney. This has been an initiative that has been in our agenda at the Miami-Dade League of Cities about maybe four or five months ago. I met Norman Powell who is an interim attorney at North Bay Village. He is a Miami Shores resident. I'm not going to read his bio even though I printed it out, but it's extensively long. I welcome you to go to the North Bay Village Council. He has a local and state municipal experience. He's got a private practice in North Bay Village. I've talked to the mayor and vice mayor there. After having a conversation with them, he seemed quite engaged.

He actually attends the Miami-Dade League of Cities which that in itself to me, I've been doing this for nine years and this is the first time that I've had a clerk and a manager that actually attends the League of Cities with us. As I said earlier in my report, there's a lot to be said about relationships. I've seen him in the last three out of six League of City meetings and we've had extensive conversations. I think you've met some of their members on the dais as well. Hold on, I have his bios right here. He is currently the interim manager at North Bay Village. I don't know if they are keeping him or not.

His private practice is at the second or third floor from the North Bay Village. As I said, his name is Norman Powell. He graduated from the Florida International University in 1987. He received his Juris Doctors from the University of Florida College of Law in 1990. He was admitted to the bar the same year. As I said, it's really extensive, so I'm going to try to pick what I would think would be-- He sat on the board of city of North Miami Beach Redevelopment and Advisory board. He sat in the Miami's first Planning and Zoning board.

He served as a special master for the city of North Miami Beach, North Bay Village.

He has served as a traffic court magistrate for Miami-Dade County. What was the other thing that I saw here? Since graduating from the University of Florida, Mr. Powell has concentrated his practice of civil litigation, real estate transactions, and state and local government law. He is a member of the city-county and local government law section of the Florida bar. He is admitted to practice before the United States supreme court. He, in '91 through '94, he successfully represented the Florida Senate in the state of Florida. Redistricting of its Senate and House District and the reappointment of Florida Congressional District.

I can go on and on. As I said, I do not know him personally at all. I have only met him through the Miami-Dade League of Cities. I've asked my peers which is the mayor of North Bay Village and the vice mayor of the North Bay Village their opinion on him. The one thing that

they said to me that was most appealing is that he attends all the meetings, he attends even meetings that not necessarily on committee or council level, but meetings with other developers and so on and so forth. It's somethings that we need right now. Whatever firm or attorney we are going to look for, we need to look for that.

I remember in 2014 when we were interviewing planning firms. It was Plosobia and there was two other really big firms. One of the reasons that the council voted for Plosobia was because there was small boutique like us because they can hand-held this throughout the whole process and you know what they do. As a result, we've been quite successful with that relationship. I applaud that attorney Geller is a big shot legislature, but we need someone that's going to be at our level and that is going to hand-held the manager, the mayor, and the council through all of these transactions that we are about to move forward and hopefully in a speedier way.

It seems that this gentleman, from the experience that he has and from what he's doing right now in North Bay Village, could be a great interim person for us. As we go through our RFQ because 100%, I really want to see what's out there. I think it's really, really important for all of us. It's time that we really take a look at all of our vendor contracts because we have long-standing relationships. The other contract we are going to be looking at is our waste management contract. Things get really hard up here because we establish such great report, but I try to make the decisions as sound as possible and with the best interest for the village.

At the end of the day, I have a job that I have to get done for you all. This would be my recommendation on an interim basis. You have a computer, you can Google him. I pass this, I see in Google you can have. If anybody has met him, I think most of you have met him at the league, but he would be my recommendation. If he could start and then I would ask the clerk to please contact him tomorrow and then we'll formalize something.

**Nickerson:** Madam mayor.

**Cubillos:** Yes.

**Nickerson:** I just have a couple of things that I just quickly want to say. First of all, because of the charter, we need to hire interim attorney. That's the first thing. Second of all, as long as that we go through the RFQ as quick as possible so that this is not lingering as far as we have an interim attorney for the next year or something like that.
