RESOLUTION NO. 2021-03

A RESOLUTION OF THE VILLAGE COUNCIL OF EL PORTAL, FLORIDA GRANTING SITE PLAN APPROVAL FOR NEW CONSTRUCTION OF AN ADDITION AT 8650 NE MIAMI COURT IN ZONE 3, SUB-URBAN RESIDENCE, IN THE VILLAGE OF EL PORTAL, AN APPLICATION BY JULIANA KOLLINGER AND WALTER GARCIA: PROVIDING FOR FINDINGS, PROVIDING FOR CONDITIONS; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, an application was submitted by Juliana Kollinger and Walter Garcia (“Applicants”) for a Site Plan Review for the construction of an addition that is greater than 50% of the existing residence at 8650 NE Miami Court pursuant of Section 17-57 of the Village of El Portal Code of Ordinances; and

WHEREAS, the proposed addition project is located in Transect Zone 3 – Sub-Urban Residence of the Village of El Portal, which consists of low-density residential areas; and

WHEREAS, on March 9, 2021, the Planning and Zoning Committee conducted a Public Hearing to consider the application and input from interested parties; and

WHEREAS, the Planning and Zoning consultants recommended approval of the site plan with certain conditions based on findings and the request being consistent with zoning requirements; and

WHEREAS, the Planning and Zoning Committee considered the recommendation of the Planning and Zoning consultants and upon conclusion of the Public Hearing voted to recommend the approval of the site plan with certain conditions to the Village Council; and

WHEREAS, on April 27, 2021, a second Public Hearing was held before the Mayor and Village Council to consider the application and interested parties were allowed to comment; and

WHEREAS, the Village Council of the Village of El Portal desires to approve the requested Site Plan for the addition at 8650 NE Miami Court with certain conditions.

NOW THEREFORE, BE IT DULY RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA THAT:

Section 1. The recitals to the preamble herein are incorporated by reference.

Section 2. **Approval of site plan.**


The Village Council hereby approves the addition of Juliana Kollinger and Walter Garcia, owners of the property located at 8650 NE Miami Court, El Portal, for site plan approval, and grants the approval for the construction of a two-story single-family residence, as requested, subject to certain conditions as set forth in the hearing.

Section 3. Effective Date.


This resolution shall take effect immediately upon adoption.


