**WHEREAS,** the Village of El Portal has been offered and would like to accept BEEFREE, LLC d/b/a FREEBEE's Master Service Agreement attached hereto as exhibit "A";

**WHEREAS,** the Village of El portal has accepted a State of Florida Department of Transportation Federal highway funds sub-recipient grant award to help pay for its shuttle pilot program;


**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, THAT:**

**Section 2.** The Village Council hereby authorizes the Village to accept the BEEFREE, LLC d/b/a FREEBEE Master Service Agreement.


**Section 3.** This resolution shall take effect immediately upon adoption.


