FDOT GRANT

A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, AUTHORIZING THE VILLAGE TO APPROVE AND ACCEPT THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION GRANT AGREEMENT FOR THE VILLAGE SHUTTLE SYSTEM; PROVIDING FOR INCORPORATION OF RECITAL; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village of El Portal would like to commence a project whereby they can offer the Village's residents express shuttle services to the Brightline station; and

WHEREAS, the Village of El Portal has been offered and would like to accept a State of Florida Department of Transportation Federal highway funds sub-recipient grant agreement to provide a sub-award of Federal Highway Administration ("FHWA") congestion mitigation grant for the express shuttle services to the Brightline station; and

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, THAT:

Section 1. The foregoing Recitals are true and correct and are incorporated herein by this reference.



Section 3. This resolution shall take effect immediately upon adoption.




