

RESOLUTION 2021 - 10

**A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, AUTHORIZING THE VILLAGE MANAGER TO USE GAS TAX RESERVE FUNDS FOR THE PAYMENT OF RIGHT OF WAY (“ROW”) TREE TRIMMING; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Village of El Portal conducts annual ROW tree trimming throughout the municipality, for the purpose of right of way maintenance; and

**WHEREAS**, that the Village of El Portal has received funds from the State Gas Tax Revenue sharing program, which can be used for roadway and right of way maintenance; and

**WHEREAS**, the Village of El Portal requires the sum of \$45,000, to be transferred from the State Gas Tax Revenue sharing account to the ROW tree trimming account; and

**WHEREAS**, the Village of El Portal currently has a contract with Orchidman Landscaping Artisan, which will be renewed for the coming year in accordance with the terms set forth in the attached Exhibit “A”; and

**NOW, THEREFORE, BE IT RESOLVED THAT, BY THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, THAT:**

**Section 1.** The foregoing Recitals are true and correct and are incorporated herein by this reference.

**Section 2.** The Village Manager is authorized to transfer \$45,000 from the State Gas Tax Revenue sharing account to the ROW tree trimming account to complete the tree trimming right of way project.

**Section 3.** The Village Manager is further authorized to expend the said funds with Orchidman Landscape Artisans for village-wide tree trimming in accordance with the attached Exhibit “A”.

**Section 4.** This resolution shall take effect immediately upon adoption.
