**COASTAL WATER RECYCLING – SOLID
WASTE COLLECTION AND DISPOSAL
SERVICES AGREEMENT**

A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, APPROVING THE SOLID WASTE COLLECTION AND DISPOSAL SERVICES AGREEMENT BETWEEN THE VILLAGE OF EL PORTAL AND COASTAL WASTE & RECYCLING; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village of El Portal issued RFP#2020-01 for residential and commercial garbage, trash, vegetation collection service for the businesses located in the Village and for citizens residing within its corporate limits; and

WHEREAS, upon completion of the review, evaluation and ranking process specified in the RFQ, Coastal Waste & Recycling was the successful Proposer; and

WHEREAS, the Village of El Portal has offered and Coastal Waste & Recycling has accepted to enter into The Solid Waste Collection and Disposal Services Agreement attached hereto as exhibit “A”;

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, THAT:

Section 1. The foregoing Recitals are true and correct and are incorporated herein by this reference.

Section 2. The Village Council hereby authorizes the Village to accept the Solid Waste Collection and Disposal Services Agreement. The attached Waste Collection and Disposal Services Agreement between the Village of El Portal and Coastal Waste & Recycling, in the form attached hereto as Exhibit A, is hereby approved and ratified, and the appropriate Village officials are authorized to execute any and all documents necessary to carrying out the terms of the attached Waste Collection and Disposal Services Agreement.

Section 3. Effective Date.

This resolution shall take effect immediately upon adoption.




