A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, APPROVING AND ACCEPTING THE EL PORTAL - COMPOST FOR LIFE - PROGRAM PROPOSAL; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village desires to provide it's community residents a compost program in an effort to divert food waste from our landfills; and

WHEREAS, Compost for Life has agreed to propose such compost program to the Village resident's in accordance to the compost for life brochure, attached hereto as exhibit "A"; and

WHEREAS, on May 4, 2021, the Village of El Portal passed the request for implementing the compost program at the Public Works Committee Meeting; and

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, THAT:

Section 1. The foregoing Recitals are true and correct and are incorporated herein by this reference.

Section 2. The Village Council hereby authorizes and accepts the Compost for Life Program Proposal attached hereto and authorizes all village officials to implement it.


Section 3. This resolution shall take effect immediately upon adoption.
