A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, AUTHORIZING, APPROVING AND ACCEPTING OF THE SELECTION OF THE VILLAGE MANAGER'S RECOMMENDATION, SOUTHEASTERN ENGINEER CONTRACTORS , AS THE CONTACTOR FOR THE EL JARDIN STORMWATER IMPROVEMENTS PROJECT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village of El Portal issued an RFQ for phase 1 construction of storm water improvements in El Jardin as shown on the Craig A. Smith & Associates, Inc. plan; and

WHEREAS, the Village Manager recommended that Southeastern Engineer Contractors be awarded the RFQ for this project; and

WHEREAS, the Village of El Portal proposes to enter into a contractual agreement for services with Southeastern Engineer Contractors for the completion of Phase 1 of the storm water improvements; and

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, THAT:


Section 1. The foregoing Recitals are true and correct and are incorporated herein by this reference.
