RESOLUTION NO. 2021- 18

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, OF MIAMI-DADE COUNTY, FLORIDA, ADOPTING THE RATE FOR SOLID WASTE AND RECYCLING SERVICES IN THE VILLAGE OF EL PORTAL; (AS INDICATED IN ATTACHMENT "A") IMPOSING SOLID WASTE AND RECYCLING ASSESSMENT FOR PROPERTY LOCATED WITHIN THE VILLAGE OF EL PORTAL FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2021; APPROVING THE RATE OF ASSESSMENT FOR THE BUDGET FOR FISCAL YEAR 2021-2022; FIXING THE TIME AND DATE FOR FINAL ADOPTION OF THE ASSESSMENT; AND DIRECTING THE VILLAGE MANAGER TO FORWARD A COPY OF THIS RESOLUTION TO THE MIAMI-DADE COUNTY PROPERTY APPRAISER OFFICE; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village of El Portal desires that Non-Ad Valorem Assessment for solid waste and recycling be printed on the TRIM notice sent out by the Miami-Dade Property Appraiser Office for fiscal year commencing on October 1, 2021; and

WHEREAS, the Village Council of the Village of El Portal, met on Tuesday, July 27, 2021 to review and consider recommendations pertaining to the proposed Non-Ad Valorem Solid Waste and Recycling Assessment, and to fix the time and date for final adoption of the proposed assessment; and

NOW, THEREFORE, BE IT RESOLVED THAT, BY THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA the rates on "Attachment A" are hereby adopted.

Section 1. The foregoing Recitals are true and correct and are incorporated herein by this reference.

Section 2. The rates on Attachment "A" for solid waste and recycling services are hereby adopted by the Village Council. Final consideration and adoption of the proposed assessment shall take place at 6:15 pm on Tuesday, September 14, 2021, at the Village Hall, 500 NE 87th St., El Portal, FL 33138.

Section 3. This resolution shall take effect immediately upon adoption.




