**A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, AUTHORIZING THE VILLAGE MANAGER OF THE VILLAGE OF EL PORTAL TO ENTER INTO AN INTERLOCAL AGREEMENT WITH MIAMI-DADE COUNTY FOR THE TRANSPORTATION CIRCULAR PILOT PROJECT SHUTTLE TO DOWNTOWN TRANSIT PROJECT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Village of El Portal would like to match the local travel needs of the Village residents while improving first and last mile connectivity in the most efficient manner possible; and

**WHEREAS**, the Village of El Portal has been offered and would like to accept the Miami – Dade County’s Interlocal Agreement for the Provision of On-Demand Services through the Transportation Circular Pilot Project Shuttle to Downton Transit Project; and

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, THAT:**


**Section 1.** The foregoing Recitals are true and correct and are incorporated herein by this reference.




