A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, AUTHORIZING THE VILLAGE TO APPROVE AND ACCEPT THE LEADING EDGE CONTRACTOR SERVICES PROPOSAL FOR A PRISON CELL CONVERSION AT THE VILLAGE OF EL PORTAL; PROVIDING FOR INCORPORATION OF RECITAL; PROVIDING FOR AN EFFECTIVE DATE.
