A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, AUTHORIZING THE VILLAGE MANAGER OF THE VILLAGE OF EL PORTAL TO ACCEPT THE APPROPRIATIONS FROM THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) FOR A TRAFFIC CALMING ROTUNDA ON THE WEST SIDE OF THE VILLAGE; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the State of Florida Department of Transportation (FDOT) has authorized a grant award to the village of El Portal in connection with the construction of a traffic calming rotunda on the West side of the Village; and

WHEREAS, the Village desires to accept the proposed grant award on the terms and conditions set forth in the grant agreement attached as Exhibit "A" hereto as incorporated by reference.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF EL PORTAL, FLORIDA, THAT:

Section 1. The foregoing Recitals are true and correct and are incorporated herein by this reference.

Section 2. The Village Council hereby authorizes the Village manager to accept the grant agreement attached hereto as exhibit "A" and authorizes the village manager to execute any and all documents necessary to accept the grant.

Section 3. This resolution shall take effect immediately upon adoption.
