A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE EL PORTAL, FLORIDA OF MIAMI-DADE COUNTY, FLORIDA, PROVIDING FOR THE PURCHASE OF ESSENTIAL POLICE EQUIPMENT FOR THE VILLAGE OF EL PORTAL OF MIAMI-DADE COUNTY; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

Section 5: That this Resolution shall become effective immediately upon its adoption.


