**A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE EL PORTAL, FLORIDA OF MIAMI-DADE COUNTY, FLORIDA, PROVIDING FOR THE PURCHASE OF ESSENTIAL POLICE EQUIPMENT “COMMUNICATION RADIO TRUNK MOUNTS” FOR THE VILLAGE OF EL PORTAL OF MIAMI-DADE COUNTY; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Village of El Portal finds the City is in need of Communication Radio Trunk Mounts (“Essential Police Equipment”) by the Village of El Portal Police Department; and

**WHEREAS**, the Village of El Portal has reviewed three sales quotations and finds that the proposed quote for the purchase of Essential Police Equipment obtained from Miami-Dade County: ITD – Radio Communications is a proper source of procurement under Florida law; and

**WHEREAS**, the Village of EL Portal hereby finds the quote from Miami-Dade County: ITD – Radio Communications (attached hereto as Exhibit A (Quote #1)) made a part of this Resolution, to be in the best interest of the Village of El Portal.

**Section 4:** The City Manager is hereby authorized to execute any necessary contracts to accomplish the intent of this Resolution.


**Section 5:** That this Resolution shall become effective immediately upon its adoption.
