

RESOLUTION NO. 2024-42

A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE EL PORTAL, OF MIAMI-DADE COUNTY, FLORIDA, ACCEPTING THE PROPOSAL FROM DMI PAVING & SEALCOATING IN CONNECTION WITH THE NATURE TRAIL PARK ADA COMPLIANT CONCRETE PAD TO SUPPORT EXERCISE EQUIPMENT FOR THE VILLAGE; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

Section 3: The Village Manager is hereby authorized to do all things necessary to carry out the aims of the Resolution.

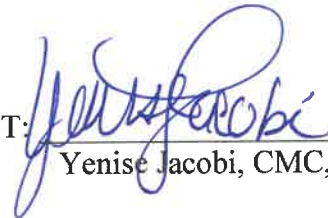
Section 4: The Village Manager is hereby authorized to execute any necessary contracts to accomplish the intent of this Resolution.

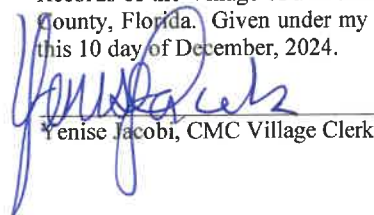
